Amman: At a meeting of the Board of Trustees of the Middle East University, chaired by the Chairman of the Board. The evening showcased the noteworthy expansion and influence of the UKDEGREESMEU initiative, which has furnished students with an exemplary academic experience and a globally recognized degree, with over 500 graduates having completed a UK degree while in Jordan.

Furthermore, he asserted that this is a significant contribution, which will become even more substantial over time.

He also emphasised the necessity of fostering collaboration in higher education, underscoring the significance of sustaining the construction of intellectual networks and the provision of avenues for prospective leaders to enhance the quality of life in their communities.

In addition, she highlighted the significance of such a collaboration in offering an unparalleled chance for those who are unable or unwilling to undertake international study, acknowledging the numerous hurdles encountered along the way, commencing with the advent of the global pandemic. In light of the numerous political shifts and other experiences, one might question whether it is possible to overcome them. However, the answer is evident today, as evidenced by the fact that we have dozens of graduates from PhD, Master's, and Bachelor's programmes, six of whom are currently employed at the university.

Alex Lambert, Director of the British Council in Jordan, characterized the partnership as a significant accomplishment, noting that it was the result of five years of rigorous effort and commitment, reflected in the achievements of 500 graduates. As a matter of support, Lambert presented attendees with the option of joining the UK Alumni Platform, which offers young people the opportunity to obtain a UK degree, either in the UK or in Jordan, and provides access to a range of valuable educational and knowledge resources.

Regarding its significance, Lambert elucidated that it is a global network that was launched almost two years ago in November 2022. In Jordan, it was launched earlier this year. It has more than 40,000 subscribers from around the world, which signifies that it is a platform with considerable potential. It offers investment opportunities for subscribers, facilitating access to diverse resources that can assist in achieving their aspirations.
